EXPEDITION SPECIALTY COURSE SWEEPSTAKES**

OFFICIAL RULES

NO PURCHASE NECESSARY

OPEN ONLY TO **TRAVEL AGENTS** WHO ARE LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA AND CANADA (EXCLUDING THE PROVINCE OF QUEBEC), AGE 18 OR OLDER.

- 1. NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES.**
- 2. ENTRY PERIOD:** The 2021 Seabourn Academy Expedition Specialty Course Sweepstakes (the “Sweepstakes”) begins at 12:00 A.M. Pacific Time (PT) on March 11, 2021, and ends at 11:59 P.M. PT on June 15, 2021 (the “Entry Period”).
- 3. HOW TO ENTER:** There are two ways to enter. An Eligible Entrant (as defined in Section 4 below) may, during the Entry Period, log in at www.seabournacademy.com, access the Expedition Specialty Course, and follow all steps to complete the Expedition Specialty Course in order to receive one (1) entry in the Sweepstakes. To complete the Seabourn Academy Expedition Specialty Course, an Eligible Entrant must complete the specialty course and pass the course exam with a score of 70% or higher. To receive one (1) Sweepstakes entry by mail without completing the Expedition Specialty Course, during the Entry Period, an Eligible Entrant may hand print his or her full name, travel agency name, mailing address, telephone number, e-mail address and date of birth on a 3” x 5” card and mail it in a stamped business-size envelope to: 2021 Seabourn Academy Expedition Specialty Course Sweepstakes Entry, Seabourn Cruise Line Limited, 450 Third Avenue West, Seattle, WA 98119 USA. Mailed entries must be postmarked during the Entry Period and received by 11:59 P.M. PT on June 22, 2021. Normal time rates, if any, charged by Internet service provider will apply. Proof of submission does not constitute proof of entry. Entry times will be determined using Sponsor’s computer, which will be the official clock for the Sweepstakes. There is a limit of one (1) sweepstakes entry per person and per e-mail address throughout the Entry Period, regardless of method of entry. All entries become the property of Seabourn Cruise Line Limited (“Sponsor”) and will not be returned, verified or acknowledged. **No purchase necessary.**
- 4. ELIGIBILITY:** The Sweepstakes is open only to individual persons who as of the date of entry are travel agents, have registered at seabournacademy.com, are legal residents of the fifty United States, the District of Columbia or Canada (excluding the Province of Quebec), and are 18 years of age or older (“Entrants” or “Eligible Entrants”). Entrants may be required to show proof of eligibility. Employees of Sponsor, its parent companies, subsidiaries, affiliates, distributors and advertising and promotion agencies (all of the foregoing, the “Sweepstakes Entities”), and such employees’ immediate family

and household members, are not eligible. Void in Quebec, U.S. territories and where prohibited by law. In the event of a dispute regarding any entry, the entry will be deemed made by the authorized account holder of the e-mail address submitted at the time of entry (i.e., the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address). Sponsor's decision is final in deciding the identity of an entrant.

5. **WINNER SELECTION:** One (1) potential Grand Prize winner will be selected in a random drawing conducted by Sponsor or its agent from all eligible entries received. Sponsor currently anticipates that the drawing for the Grand Prize will take place on or about July 1, 2021. Odds of winning depend on the number of eligible entries received.
6. **WINNER NOTIFICATION AND VERIFICATION:** The potential winner is subject to verification. The potential winner will be notified by email, mail or phone, in Sponsor's discretion. The potential winner will be required to sign and return to Sponsor, within 10 days of the date notice or attempted notice is sent, an Affidavit of Eligibility and Liability & Publicity Release and all information required for tax reporting, as applicable, per in Section 6 herein, in order to claim his/her prize. If the potential winner is unreachable or fails to respond to any notification during a period of forty-eight (48) consecutive hours (Sponsor may elect not to leave messages on answering machines), or if the potential winner fails to respond or fails to sign and return the Affidavit of Eligibility and Liability & Publicity Release within the required time period, or if any attempted notification or prize delivery is returned as undeliverable, the potential winner may be disqualified and an alternate winner may be selected. 7. **PRIZE:** One (1) Grand Prize: One (1) Seabourn Cruise Line cruise of up to seven (7) days for the winner and one (1) guest, departing before December 31, 2022, subject to availability at time of confirmation. Approximate Retail Value ("ARV") \$12,288 USD / \$15,509 CAD.

The Grand Prize winner and his/her guest must travel together in the same stateroom on the same itinerary. The Grand Prize consists of suite accommodations for the winner and one (1) guest (same stateroom). Stateroom category will be assigned by Sponsor. Holiday

cruise dates are excluded. Grand Prize winner and guest are NOT eligible for Seabourn Cruise Line air/sea programs or Seabourn Cruise Line's SeabournShield program.

No substitution of any prize or any component thereof is permitted, except in the discretion of Sponsor, which reserves the right to substitute a prize or prize component of equal or greater value. Prize will be awarded only to a Winner with a residential address within the United States, DC, or Canada (excluding Quebec, residents of which are ineligible to participate in this Sweepstakes).
